- (iii) the new entity's operations are limited to Australia and New Zealand only

If newly formed or newly acquired entities or joint ventures fall outside the criteria mentioned in (i), (ii) or (iii) above then the inclusion of such newly formed or acquired entities is to be agreed by Insurers and additional premium or other specific terms may be applied by Insurers.

If the Insurers allege that by reason of this exclusion, any loss, injury, damage, cost or expense is not covered by this insurance the burden of proving the contrary shall be upon the Insured.
